

Proflora Feminine

Food Supplement of Lactic Acid Bacteria and Cranberry Extract for the Health of Urogenital Tract in Women.

Indication:

To treat Bacterial Vaginosis (BV) & Urinal Tract Infections (UTI).

Other ingredients: Hydroxypropylmethylcellulose (capsule), Rice Bran dry extract (anticaking agent), Rice Cuticle concentrated powder (anticaking agent).

Recommended daily intake: 2 capsules per day for 6 days (treatment). For prophylaxis, one capsule can be taken daily.

Instructions of use:

Swallow the capsule / capsules with a glass of water or sprinkle on top of breakfast cereals or yoghurt.

Situations of use:

Period of symptoms of;

- Unbalanced vaginal flora (alkaline) accompanied by discharge, bad odour, pain, itching, or burning and/or
- Urinary tract infection including cloudy urine, pain or discomfort when urinating, increased frequency of urinating.

Escherichia coli is the most prevalent cause of UTIs. Cranberry (CranMax) inhibits the adhesion of E. coli in the urinal tract and reduces infection.

Lactic acid bacteria produce a natural antibacterial substance, which may reduce recurrent UTI.

Proflora Feminine may balance vaginal microflora.

Proflora Feminine contains riboflavin (Vitamin B2) which contributes to the maintenance of normal mucous membranes.

Adverse effects and precautions:

- The product has no known adverse effects and no special precautions need to be taken for otherwise healthy people.
- Pregnant women should only take the supplement after prior approval by a medical doctor or other health care professional.
- Do not use if you have allergy to any of the ingredients of the product.
- Do not exceed the recommended dosage.
- Do not use as a substitute for a varied diet.

Storage

Keep out of the reach of children, below 25°C and away from moisture.
